- (1) The phantom stock units were accrued in Mr. Policano's Badger Meter, Inc. Director Deferred Compensation Plan account as payment for half of the second quarter retainer paid to non-employee directors in the amount of \$2,250. The phantom units are computed at the 3/31/06 closing price of the Company's stock. The remaining half of the retainer is paid into a cash deferred account under the same Plan. In addition to the phantom shares, Mr. Policano owns 7,500 shares of Common Stock directly.
