- (1) Includes 574.559 shares acquired through the Home BancShares, Inc. 401(k) Plan since the last filing. These performance based stock options were granted in March 2006 under the Home BancShares, Inc. 2006 Stock Option and Performance Incentive Plan. For the person to become eligible, the Company has to meet certain objectives each year. As a result of the Company's 2007 performance, 20% of the total options granted were approved for eligibility by the Company's Compensation Committee.
- (3) The option is exercisable in five equal annual installments. The first installment became exercisable on December 31, 2004.
- (4) The option expires 10 years from the exercisable date, therefore the first installment became exercisable on December 31, 2004 and expires on December 31, 2014.
