(1) Pursuant to the Endo Pharmaceuticals Directors Stock Election Plan, on June 27, 2008 (the day following his election to the Endo Board of Directors), Mr. Scodari elected to receive 100% of his 2008 cash retainer fees in Endo common stock. At the time that the retainer fees would otherwise have been payable, the number of shares of Endo common stock are fixed and are reported as of such date on Table I as an acquisition of securities. These cash retainer fees are payable to Mr. Scodari in consideration of his services on the Endo Pharmaceuticals Holdings Inc. Board of Directors, and the amount reported on this Form represent Mr. Scodari's third quarter 2008 retainer fees.

(2) Mr. Scodari's beneficial ownership of non-derivative securities includes 2,525 shares of Endo common stock and 2,118 restricted stock units granted under the Endo 2007 Stock Incentive Plan.
