- (1) 2,490 shares of restricted stock issued to the Reporting Person under the Republic Services, Inc. 2005 Non-Employee Director Equity Compensation Plan (f/k/a Allied Waste Industries, Inc. 2005 Non-Employee Director Equity Compensation Plan).
 - (2) Stock issued to Blackstone Management Partners III L.L.C. ("BMP III"), the Investment Advisor to certain of the Blackstone entities invested in the Issuer, of which Reporting Person is a member. Reporting Person disclaims any beneficial ownership in the stock issued to BMP III. The stock was issued to BMP III as part of Reporting Person's compensation as a member of the Board of Directors of the Issuer.
