The restricted stock units shall vest as follows: 2,000 units shall vest immediately on the date of grant and the remaining 8,000 units shall vest in one-tenth (1/10) increments monthly until May 8, 2010; provided, however, that the shares underlying the restricted stock units shall not be issued to the directors until the director's cessation of service on the Board of Directors.
