(1) The reporting person was granted an option to purchase 72,697 shares of common stock from the Company as compensation in connection with his continuing employment. The option was granted pursuant to the HealthSpring, Inc. Amended and Restated 2006 Equity Incentive Plan. In general, the shares subject to this option will vest and become exercisable as follows: 50% on March 7, 2013; 25% on March 7, 2014; and 25% on March 7, 2015. The reporting person was also granted an option to purchase 72,697 shares of common stock from the Company as compensation in connection with continuing employment, which award is not reported herein. Such additional option vests and becomes exercisable based on future Company financial performance.
