- (1) Represents shares tendered to Sentinel Acquisition Corporation ("Sentinel") pursuant to the Offer to Purchase, dated March 7, 2011. Represents unvested restricted shares held by the Reporting Person. Pursuant to the Agreement and Plan of Merger, dated March 2, 2011, between Global Defense Technology & Systems, Inc., Sentinel, and Sentinel Acquisition Holdings Inc. (the "Merger Agreement"), these shares were canceled in exchange for a cash payment of \$24.25 per share.
- (3) Under the Merger Agreement, this option, which provided for vesting in four equal annual installments beginning February 26, 2011, was canceled in exchange for a cash payment representing the difference between \$24.25 per share and the exercise price of the option.
