- (1) Restricted stock units (RSUs) that vest in full on January 31, 2013, subject to continued employment with Sara Lee through that date, and upon vesting will be converted into shares of Sara Lee common stock on a one-for-one basis; provided that upon completion of Sara Lee's publicly announced plan to spin-off its coffee and tea business into an independent publicly traded company, the RSUs will vest on a pro rata basis and will be converted into shares of the spun-off coffee and tea company rather than shares of Sara Lee.
- (2) Includes 291,618 RSUs that may be settled only for shares of common stock. RSUs generally vest one to five years after grant date subject to the reporting person's continued employment with Sara Lee; however, upon completion of the plan, announced by Sara Lee on January 28, 2011, to divide the company into two separate, publicly traded companies, any outstanding equity then held by the reporting person will vest in full.
