(1) Shares of common stock issued upon settlement of phantom stock units accrued in Sara Lee's Non-Employee Director Deferred Compensation program. Phantom units were converted into common stock, on a one-for-one basis, on the date previously specified by the reporting person.

(2) Includes 67,129 RSUs that may be settled only for shares of common stock. RSUs generally vest one year after the grant date and, on the settlement date, are convertible into shares of common stock on a one-for-one basis. The settlement date is six months after the reporting person ceases to be a director of Sara Lee.

(3) Includes 363 RSUs acquired in the company's dividend reinvestment plan with accrued dividend equivalents.

(4) Represents director fees deferred and dividend reinvestment credits accrued in the reporting person's account in the Sara Lee Corporation Non-Employee Director Deferred Compensation Program. Phantom stock units will be settled only for shares of Sara Lee common stock on a one-for-one basis on the dates previously specified by the reporting person.
