On December 31, 2012, the cumulative 3-year performance period for Mr. Levin's February 19, 2010 grant of performance shares concluded. At this time, the performance shares were converted into 32,023 shares of common stock. Of this amount, 14,237 shares were withheld by the issuer to satisfy tax obligations on shares acquired and 17,786 shares were transferred to Mr. Levin effective immediately.

(1) This represents the automatic conversion of performance shares granted to Mr. Levin on February 19, 2010 to shares of Endo Health Solutions Inc. common stock pursuant to the terms of the underlying award agreement.
