- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing May 15, 2014.
- (2) No transaction is being reported on this line. Reported on a previously filed Form 3, Form 4, or Form 5.
- (3) The reporting person holds previously reported options to buy 23,865 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between December 15, 2003 and August 20, 2008, at exercise prices between \$23.71 to \$47.01 per share, will expire between December 15, 2013 and August 20, 2018 and became or will become exercisable between December 31, 2004 and September 30, 2012.
- (4) The current balance reflects the expiration of 4,914 options on February 6, 2013 and 2,000 options on March 12, 2013.
