(the "Company") theretofore owned by JLL Partners Fund IV, L.P. to its partners (the "Distribution"), of which 1,334,700 shares of common stock were distributed to JLL Associates IV, L.P., the general partner of JLL Partners Fund IV, L.P.
- (2) Mr. Levy is the managing member of JLL Associates G.P. IV, L.L.C., which is the general partner of JLL Associates IV, L.P., which in turn is the general partner of JLL Partners Fund IV, L.P. Although Mr. Levy may be deemed to be an indirect beneficial owner of 1,883,870 shares of the Company's common stock, which is comprised of 1,334,700 shares directly owned by JLL Associates IV, L.P. and 549,170 shares directly owned by an entity owned by Mr. Levy, Mr. Levy disclaims beneficial ownership of the shares directly owned by JLL Associates IV, L.P., except to the extent of any pecuniary interest therein.
