- (1) Each RSU represents a contingent right to receive 1 share of the issuer's Class A Common Stock upon vest.

The RSUs were subject to a performance-based vesting condition designed to qualify such award as tax-deductible compensation under Section 162(m)(4)(c) of the Internal Revenue Code. If the Issuer does not satisfy the performance-based condition, none of the RSUs shall vest. Upon satisfaction of the performance-based condition, 15% of the RSUs will vest on the later of the date in which the
 - (2) Compensation Committee of the Issuer determines that the performance-based condition has been met and the anniversary of the vesting commencement date of February 15, 2014, 20% of the RSUs will vest on the second anniversary of the vesting commencement date, 25% of the RSUs will vest on the third anniversary of the vesting commencement date and 40% of the RSUs will vest on the fourth anniversary of the vesting commencement date, subject to continued service to the Issuer through each such date.
 - (3) The RSUs were granted to the Reporting Person on March 14, 2014 and the Compensation Committee of the Issuer certified that the performance-based condition was met on February 19, 2015.
 - (4) On February 19, 2015, the date of the Issuer's Compensation Committee meeting, the performance-based condition for vesting was met, at which time the RSU was issued. Because the first possible vesting date had passed, the initial tranche of RSUs immediately vested.
