- (1) This amendment is being filed to correct a scrivener's error with regards to the number of derivative securities acquired on February 20, 2017. The Form 4 reporting the transaction incorrectly recorded the number of derivative shares as 156,752. The number of derivative shares acquired on February 20, 2017 has been corrected to 78,376.
 - (2) Each restricted stock unit ("RSU") represents a contingent right to receive, upon vesting, one share of common stock, par value Euro 0.01 per share, of Frank's International N.V.
 - (3) The 78,376 RSUs reported on this Form 4 will vest ratably in three annual installments beginning on February 20, 2018.
 - (4) Also consists of 28,261 RSUs that will vest ratably in three annual installments beginning on November 15, 2017.
