Pursuant to the issuer's Board of Directors Compensation Plan, the Board of Directors granted \$100,000 of common stock to each non-employee director under the issuer's 2015 Equity Incentive Plan, based on the \$18.61 closing price of the stock on June 5, 2018 as quoted on the NASDAQ Global Select Market.
