(1) Includes 21,578 restricted stock units (RSUs) mandatorily deferred by CNS from the reporting person's annual incentive performance bonus, plus 5,394 RSUs granted to the reporting person as a company match on such deferral. Dividends paid on CNS common stock are reflected in additional RSUs on such deferred and matching RSUs. The deferred and matching RSUs vest ratably over four years, and the dividend RSUs vest on the fourth anniversary of the grant.

(2) Footnote 1 continued: Also includes 11,009 RSUs voluntarily deferred by the reporting person from his annual incentive performance bonus, plus 2,752 RSUs granted to him as a company match on such deferral. Dividends paid on CNS common stock are reflected in additional RSUs on such deferred and matching RSUs.
