( Aeropar ), concluded a restructuring of its corporate shareholdings, by means of which 31,493,863 preferred shares of GOL, held by Aeropar, were transferred to the Fundo de Investimento em Participações Asas ( Fund ). Comporte Participações S.A. ( Comporte ) also transferred its 3,351,775 preferred shares of GOL to the same Fund.
