### **Transfer of Rights and Capitalization**

Rio de Janeiro, June 22 2010, Petróleo Brasileiro S.A. - Petrobras announces that the National Petroleum Agency (ANP) has confirmed that the procedure to hire the certifying company that will issue an opinion to assist the Federal Government in its negotiation regarding the value of the Transfer of Rights is in its final stage, and that such opinion is scheduled to be delivered by August 2010.

Petrobras has therefore decided to postpone the proposed public offering of Petrobras shares, with the goal of executing the proposed offering in September of this year in an amount necessary to enable it to fund the 2010-14 Business Plan, to maintain its leverage level in the range disclosed in the Business Plan and to pay for the Transfer of Rights, as approved by the Brazilian Congress and currently under negotiation with the Brazilian federal government.

The Company announces that it will remain in the quiet period, as determined under art. 48 of Brazilian Securities Commission (CVM) Instruction 400/03, until the closing of the offering; and that it will continue both disclosing data to the market regarding the normal course of its activities, and information about the public offer, under the terms of the applicable regulations.

This announcement is not an offer of Petrobras shares. Petrobras shares may not be offered or sold in the United States absent registration or an exemption from registration, and Petrobras currently intends to register the proposed offering in the United States. Any public offering of Petrobras shares will be made by means of a prospectus containing detailed information about Petrobras and the offering.
