Item 2.05 Costs Associated with Exit or Disposal Activities.

On September 27, 2005, ADC Telecommunications, Inc. (the "Company") determined that it intends to relocate certain manufacturing operations from England and Scotland to a location offering lower costs. In connection with this relocation, approximately 150 ADC employees would be made redundant in England and Scotland. This represents less than 2% of ADC's worldwide workforce.

The expected completion date is unknown. Because the details of the relocation have not yet been finalized, the Company is not able to provide the estimated cost at this time. The Company will file a further report on Form 8-K under Item 2.05 within four business days after it makes a determination of such an estimate or range of estimates.
