Effective September 22, 2011, the Board of Directors of Piper Jaffray Companies (the "Company") increased the size of the Board by one, to nine directors, and elected Hope B. Woodhouse to serve as a director of the Company for an initial term expiring at the Company's 2012 annual meeting of shareholders.
