(1) The original Form 4 reported that the number of shares withheld to pay tax withholding obligations to appropriate taxing authorities from the lapse of the restrictions on Reporting Person's restricted stock effective October 29, 2008 was 72,717 shares. Subsequent to the filing date of the Form 4 the actual number of shares withheld was finalized and is reported in this Amended Form 4. This withholding was approved by the Personnel & Compensation Committee of Delta's Board of Directors and is exempt from Section 16(b) of the Securities Exchange Act of 1934 under Rules 16b-3(d)(1) and 16b-3(e).
