ATHENS, GREECE, July 26, 2011 Star Bulk Carriers Corp. (the Company or Star Bulk) (Nasdaq: SBLK) today announced that it will release its results for the second quarter and first half 2011 before the market opens in New York on Wednesday, August 10, 2011. Star Bulk's management team will host a conference call to discuss the Company's financial results on the same day, Wednesday, August 10, 2011, at 11:00 a.m. Eastern Daylight Time (EDT).

Star Bulk is a global shipping company providing worldwide seaborne transportation solutions in the dry bulk sector. Star Bulk's vessels transport major bulks, which include iron ore, coal and grain and minor bulks such as bauxite, fertilizers and steel products. Star Bulk was incorporated in the Marshall Islands on December 13, 2006 and maintains executive offices in Athens, Greece. Its common stock trades on the Nasdaq Global Market under the symbol "SBLK". Currently, Star Bulk has an operating fleet of eleven dry bulk carriers, definitive agreements to build two Capesize vessels and definitive agreements to acquire two Capesize vessels. The total fleet consists of fifteen vessels, seven Capesize, and eight Supramax dry bulk vessels with a combined cargo carrying capacity of 1,626,721 deadweight tons. The average age of our current operating fleet is approximately 11 years.
