STAR BULK ANNOUNCES THE SALE OF M/V STAR JULIA FOR DEMOLITION

ATHENS, GREECE, January 23, 2015 Star Bulk Carriers Corp. (the Company or Star Bulk) (Nasdaq: SBLK) a global shipping company providing transportation solutions in the dry bulk sector, today announced that it has entered into a binding agreement to sell for demolition the M/V Star Julia (ex Powerful, the Vessel), a 70,100 dwt Panamax vessel, built in 1994, to an unaffiliated third party (the Buyers), at a profit over net book value. The Company expects to deliver the Vessel to the Buyers by early February 2015.

Star Julia was acquired from Excel Maritime Carriers Ltd (Excel) under an en bloc transaction of 34 vessels on August 19, 2014.

This transaction is in line with the Company s strategy to opportunistically divest assets that do not fit the profile of its fleet and further solidify its balance sheet.

About Star Bulk

Star Bulk is a global shipping company providing worldwide seaborne transportation solutions in the dry bulk sector. Star Bulk is vessels transport major bulks, which include iron ore, coal and grain and minor bulks which include bauxite, fertilizers and steel products. Star Bulk was incorporated in the Marshall Islands on December 13, 2006 and maintains executive offices in Athens, Greece. Its common stock trades on the Nasdaq Global Select Market under the symbol "SBLK". On a fully delivered basis, Star Bulk will have a fleet of 101 vessels, with an aggregate capacity of 11.7 million dwt, consisting of Newcastlemax, Capesize, Kamsarmax, Panamax, Post-Panamax, Ultramax, Supramax and Handymax vessels with carrying capacities between 45,590 dwt and 209,000 dwt. Our fleet currently includes 65 operating vessels, 3 second hand vessels to be delivered in early 2015 and 34 newbuilding vessels currently under construction at shipyards in Japan and China. All of the newbuilding vessels are expected to be delivered during 2015 and 2016.
