- (1) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of (1) 45,000 shares of restricted stock granted to the Reporting Person on 3/1/07, (2) vesting of 97,195 shares of restricted stock granted to the Reporting Person on 3/3/08 (3) vesting of 30,000 shares of restricted stock granted to the Reporting Person on 3/3/08 (4) vesting of 94,357 shares of restricted stock granted to the Reporting Person on 3/2/09 and (5) vesting of 3,128 shares of restricted stock granted to the Reporting Person on 3/3/09.
