Dear Customer and Partner,

We're sure you are by now aware of the important announcement re: Alcatel's proposed merger with Lucent Technologies. We're also sure you are eager to understand more about the consequences on our Enterprise activities, and the potential impact on our business relationship with you.

As you know, Lucent, unlike Alcatel, no longer has any Enterprise activities (spun-off in 2000 under the Avaya name). As a result, there is no overlap or adverse effect from the combination. Quite the opposite, as the two groups actually share an identical vision of the role of Enterprise in a global communications market:

- technical commonalities with carrier solutions, especially in an IMS world;
- diversity and depth of the customer base beyond service providers;
- flexibility in delivery models, from enterprise-based solutions to carrier-hosted applications – something Alcatel has pioneered under its Managed Communications Services strategy.

Ms. Patricia Russo, Lucent's Chairman & CEO, and future CEO of the combined ensemble, actually led Lucent's enterprise activities before they were spun-off, and publicly stated on several occasions her regrets about Lucent's former management having decided to spin-off Avaya. She recently expressed her full support to a global Enterprise strategy within the new Alcatel-Lucent combination.
