- (2) Shares withheld to cover required tax withholding on vesting of restricted stock effective as of 05/05/2011 - data provided by plan administrator on 05/06/2011.

- (4) One share of Apache common stock for each restricted stock unit.
- (5) Restricted stock units granted 05/04/2011 under employer plan - data received from plan administrator on 05/06/2011. The units vest 25% per year on 06/01/2012, 05/04/2013, 05/04/2014 and 05/04/2015.
- (6) Stock option granted 05/04/2011 under employer plan - data received from the plan administrator on 05/06/2011. Exercisable ratably over four years beginning 05/04/2012.
