- (1) Represents shares of common stock sold pursuant to a 10b5-1 trading plan entered into as of August 25, 2015 to satisfy the reporting person's tax obligations upon vesting of 10,833 restricted stock units ("RSUs")
- (2) Weighted average price. These shares were sold in multiple transactions at prices ranging from \$1.02 to \$1.06 inclusive.
