On November 9, 2018, Citizens Community Bancorp, Inc. (the "Company") issued a press release announcing that Citizens Community Federal National Association ("CCF Bank"), a wholly-owned subsidiary of the Company, appointed Michael R. Prior to her position with OEM Fabricators, Ms. Skarvan served in various roles at Hutchinson Technology Incorporated, most recently as the President of the Disk Drive Components Division from April 2007 until March 2011. She has served on the Board of Trustees of the St. Cloud State University Foundation since June 2015. Ms. Skarvan has a bachelor's degree from St. Cloud State University.
