**Item 1.01. Entry Into a Material Definitive Agreement**

On October 7, 2015, Kimco Realty Corporation ( Kimco ) entered into an underwriting agreement (the Underwriting Agreement ) with Citigroup Global Markets Inc., RBC Capital Markets, LLC and Wells Fargo Securities, LLC, as representatives of the several underwriters (collectively, the Underwriters ), pursuant to which Kimco agreed to sell \$500 million in aggregate principal amount of 3.400% Notes due 2022 (the Notes ). The Notes are being offered and sold under a prospectus supplement and related prospectus filed with the Securities and Exchange Commission pursuant to Kimco s shelf registration statement on Form S-3 (File No. 333-202389). A copy of the Underwriting Agreement is attached hereto as Exhibit 1.1 and is incorporated by reference herein. Certain of the Underwriters and their affiliates may be customers of, engage in transactions with, and perform services for Kimco and its subsidiaries in the ordinary course of business.
