Sabby Management, LLC, a Delaware limited liability company, indirectly owns 1,278,772 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Volatility Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., Cayman Islands companies that directly hold 852,516 and 426,256 shares of Common Stock, respectively. Mr. Mintz indirectly owns 1,278,772 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
