Sabby Management, LLC, a Delaware limited liability company, indirectly owns 1,147,989 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd. Mr. Mintz indirectly owns 1,147,989 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
