On June 25, 2018, Nanometrics Incorporated informed Jonathan H. Chou, Nanometrics' Chief Financial Officer, that Mr. Chou would cease to be an officer and employee of Nanometrics. Mr. Chou's last day of employment was June 25, 2018.
