On November 29, 2018, vTv Therapeutics Inc. (the “Company”) exercised its right to cause MacAndrews & Forbes Group LLC (the “Investor”) to purchase 1,879,700 shares of the Company’s Class A common stock at a per share price of \$1.33 pursuant to the terms of the letter agreement between the Company and the Investor dated July 30, 2018 (the “2018 Letter Agreement”). The Investor funded \$2.5 million to the Company in exchange for 1,879,700 shares of Class A common stock following the execution of definitive documentation by and between the Company and the Investor.

The foregoing disclosure regarding the 2018 Letter Agreement is qualified in its entirety by reference to the 2018 Letter Agreement, attached as Exhibit 10.1 to the Company’s Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission (the “SEC”) on November 8, 2018.
