## Explanation of Responses:

- (1) Represents the weighted average price of shares sold at prices that ranged from \$33.99 to \$34.02.
- (2) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 10/1/14 and 1/48th per month thereafter.
