(1) On January 27, 2017, 243 Restricted Share Units, which represent the right to receive one share of Crane Co. Common Stock, previously reported as beneficially owned by the reporting person, vested due to the passage of time, and 80 shares were withheld to pay taxes on the resulting gain, resulting in a net issuance of 163 shares of Crane Co. Common Stock.
