Pursuant to the instructions in Item 7 of Schedule 13G, Fidelity Management & Research Company ("Fidelity"), 82 Devonshire Street, Boston, Massachusetts 02109, a wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 10,568,972 shares or 15.031% of the Common Stock outstanding of Mannkind Corporation ("the Company") as a result of acting as investment adviser to various investment companies registered under Section 8 of the Investment Company Act of 1940. The number of shares of Common Stock of Mannkind Corporation owned by the investment companies at December 31, 2006 included 222,501 shares of Common Stock resulting from the assumed conversion of \$5,000,000 principal amount of MANNKIND CORP CV 3.75% 12/13 (44.5002 shares of Common Stock for each \$1,000 principal amount of

debenture). The number of shares of Common Stock of Mannkind Corporation owned by the investment companies at December 31, 2006 included 420,950 shares of Common Stock resulting from the assumed conversion of 420,950 shares of MANNKIND WT 8/3/10 (1 shares of Common Stock for each warrant).

The ownership of one investment company, Fidelity Contrafund, amounted to 5,073,697 shares or 7.215% of the Common Stock outstanding. Fidelity Contrafund has its principal business office at 82 Devonshire Street, Boston, Massachusetts 02109.

Edward C. Johnson 3d and FMR Corp., through its control of Fidelity, and the funds each has sole power to dispose of the 10,568,972 shares owned by the Funds.

Members of the family of Edward C. Johnson 3d, Chairman of FMR Corp., are the predominant owners, directly or through trusts, of Series B shares of common stock of FMR Corp., representing 49% of the voting power of FMR Corp. The Johnson family group and all other Series B shareholders have entered into a shareholders' voting agreement under which all Series B shares will be voted in accordance with the majority vote of Series B shares. Accordingly, through their ownership of voting common stock and the execution of the shareholders' voting agreement, members of the Johnson family may be deemed, under the Investment Company Act of 1940, to form a controlling group with respect to FMR Corp.

Neither FMR Corp. nor Edward C. Johnson 3d, Chairman of FMR Corp., has the sole power to vote or direct the voting of the shares owned directly by the Fidelity Funds, which power resides with the Funds' Boards of Trustees. Fidelity carries out the voting of the shares under written guidelines established by the Funds' Boards of Trustees.

Strategic Advisers, Inc., 82 Devonshire Street, Boston, MA 02109, a wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, provides investment advisory services to individuals. As such, FMR Corp.'s beneficial ownership includes 47,500 shares, or 0.068%, of the Common Stock stock outstanding of Mannkind Corporation, beneficially owned through Strategic Advisers, Inc.

Pyramis Global Advisors, LLC ("PGALLC"), 53 State Street, Boston, Massachusetts, 02109, an indirect wholly-owned subsidiary of FMR Corp. and an investment adviser registered under Section 203 of the Investment Advisers Act of 1940, is the beneficial owner of 2,900 shares or 0.004% of the outstanding Common Stock of Mannkind Corporation as a result of its serving as investment adviser to institutional accounts, non-U.S. mutual funds, or investment companies registered under Section 8 of the Investment Company Act of 1940 owning such shares.

Edward C. Johnson 3d and FMR Corp., through its control of PGALLC, each has sole dispositive power over 2,900 shares and sole power to vote or to direct the voting of 2,900 shares of Common Stock owned by the institutional accounts or funds advised by PGALLC as reported above.

Edward C. Johnson 3d has sole voting and dispositive power over 5,600 shares, shared voting and dispositive power over 0 shares, and no voting or dispositive power over 0 shares.

Fidelity International Limited ("FIL"), Pembroke Hall, 42 Crow Lane, Hamilton, Bermuda, and various foreign-based subsidiaries provide investment advisory and management services to a number of non-U.S. investment companies and certain institutional investors. FIL, which is a qualified institution under section 240.13d-1(b)(1) pursuant to an SEC No-Action letter dated October 5, 2000, is the beneficial owner of 9,000 shares or 0.013% of the Common Stock outstanding of the Company. The number of shares of Common Stock of Mannkind Corporation owned by the institutional account(s) at December 31, 2006 included 218,496 shares of Common Stock resulting from the assumed conversion of \$4,910,000 principal amount of MANNKIND CORP CV 3.75% 12/13 (44.5002 shares of Common Stock for each \$1,000 principal amount of debenture). The number of shares of Common Stock of Mannkind Corporation owned by the institutional account(s) at December 31, 2006 included 29,881 shares of Common Stock resulting from the assumed conversion of 29,881 shares of MANNKIND WT 8/3/10 PIPE P/P (1 shares of Common Stock for each share of Convertible Preferred Stock). The number of shares of Common Stock of Mannkind Corporation owned by the institutional account(s) at December 31, 2006 included 149,406 shares of Common Stock resulting from the assumed conversion of 149,406 shares of MANNKIND CORP PIPE P/P (1 shares of Common Stock for each share of Convertible Preferred Stock).

Partnerships controlled predominantly by members of the family of Edward C. Johnson 3d, Chairman of FMR Corp. and FIL, or trusts for their benefit, own shares of FIL voting stock with the right to cast approximately 47% of the total votes which may be cast by all holders of FIL voting stock. FMR Corp. and FIL are separate and independent corporate entities, and their Boards of Directors are generally composed of different individuals.

FMR Corp. and FIL are of the view that they are not acting as a "group" for purposes of Section 13(d) under the Securities Exchange Act of 1934 (the "1934" Act) and that they are not otherwise required to attribute to each other the "beneficial ownership" of securities "beneficially owned" by the other corporation within the meaning of Rule 13d-3 promulgated under the 1934 Act. Therefore, they are of the view that the shares held by the other corporation need not be aggregated for purposes of Section 13(d). However, FMR Corp. is making this filing on a voluntary basis as if all of the shares are beneficially owned by FMR Corp. and FIL on a joint basis.
