REPORTS ON OPERATIONS  
FOR THREE MONTHS AND NINE MONTHS ENDED APRIL 30, 2012

J. W. Mays, Inc. today reported its financial results for the three and nine months ended April 30, 2012.

Revenues from Continuing Operations for the three months ended April 30, 2012, were \$4,181,446 compared to revenues of \$3,794,152 in the comparable 2011 three-month period, while revenues from Continuing Operations for the nine months ended April 30, 2012, were \$12,273,220 compared to revenues of \$11,109,373 in the comparable 2011 nine-month period.

Net income from Continuing Operations for the three months ended April 30, 2012, was \$140,159, or \$.07 per share, compared to net income from Continuing Operations of \$213,627, or \$.11 per share, in the comparable 2011 three-month period. Net income from Continuing Operations for the nine months ended April 30, 2012, was \$826,081, or \$.41 per share, compared to net income from Continuing Operations of \$382,968, or \$.19 per share, in the comparable 2011

nine-month period.

There was no income (loss) from Discontinued Operations for the three months ended April 30, 2012, compared to a net loss from Discontinued Operations of (\$10,411), or (\$.00) per share, in the comparable 2011 three-month period.

There was no income (loss) from Discontinued Operations for the nine months ended April 30, 2012, compared to a net loss of (\$187,771), or (\$.09) per share, in the comparable 2011 nine-month period.

Net income for the three months ended April 30, 2012 was \$140,159, or \$.07 per share, compared to net income of \$203,216, or \$.11 per share, in the comparable 2011 three-month period.

Net income for the nine months ended April 30, 2012, was \$826,081, or \$.41 per share, compared to net income of \$195,197, or \$.10 per share, in the comparable 2011 nine-month period.
