Represents a Restricted Stock Award from Adaptec Inc's 2006 Director Plan for 16,250 shares of common stock that would vest with respect to 33.33% of the shares on October 23, 2009 and 8.33% of the shares quarterly thereafter, such that the award is fully vested on October 23, 2011.

A total of 32,500 of Non-Qualified Stock Options were granted on October 23, 2008 from Adaptec Inc's 2006 Director Plan. The option shall vest at a rate of 33.33% of the shares on October 23, 2009 and 8.33% of the shares quarterly thereafter, such that the total option shares will be fully vested on October 23, 2011.
