On November 28, 2016, director James C. Wheat, III notified the Board of Directors of Dynex Capital, Inc. ("Dynex") of his decision to not stand for re-election to Dynex's Board of Directors (the "Board") at the 2017 Annual Meeting of Shareholders in order to focus on other business commitments, with his Board service to end effective as of the close of business on December 31, 2016. Dynex's Board does not currently intend to replace Mr. Wheat on the Board and may reduce the size of the Board to six members effective as of the close of business on December 31, 2016.
