**ITEM 1.01. Entry into a Material Definitive Agreement**

On April 19, 2005, the Board of Directors of Aztar Corporation appointed Gordon M. Burns, a current Director, as the independent Lead Director. In addition to his normal Board of Directors fees, Mr. Burns will be paid an additional fee of \$10,000 per year for additional services as Lead Director.

The Lead Director shall have authority to call meetings of the independent directors, shall preside over scheduled meetings of the independent directors, and shall perform other functions as directed by the Board.
