Item 1. Security and Issuer

This Amendment No. 2 to Schedule 13D relates to the common stock, par value \$1.00 per share (the "Common Stock"), of the following corporation (the "Issuer" or the "Company"):

Item 2. Identity and Background

This Amendment No. 2 to Schedule 13D is filed on behalf of Holland M. Ware, whose business address is 212 Maple Drive Hogansville, GA 30230, and David C. Cook, whose business address is One Independent Drive Suite 1300, Jacksonville, FL 32202, to report the disposition of shares of Common Stock.

Mr. Ware is currently a self-employed real estate investor. Mr. Cook is a partner in the law firm of Foley & Lardner LLP.

During the last five years, neither Mr. Ware nor Mr. Cook has been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanors).

During the last five years, neither Mr. Ware nor Mr. Cook has been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Mr. Ware and Mr. Cook are both citizens of the United States.

Item 3. Source and Amount of Funds or Other Consideration

The source of funds used to acquire the shares reported herein by Mr. Ware and Mr. Cook were their respective personal funds.

Item 4. Purpose of Transaction

On December 12, 2008, Mr. Ware advised the Company of his desire to acquire the Company.

On January 9, 2009, Mr. Ware reiterated to the Company his continuing desire to purchase the Company and advised that he was prepared to make a cash tender offer for any and all shares at \$ 15 per share if the Forestar Board of Directors supported the tender offer and they were able to mutually agree on related matters such as board representation and waiver of the Rights Plan.

On January 21, 2009, Mr. Ware requested that the Board promptly form a special committee of independent directors and engage a independent financial advisor to fully consider and act upon his offer to acquire the Company for a cash price of \$15 per share. Mr. Ware requested a prompt formal, written answer from the independent directors regarding his offer.

The Company has never provided any substantive feedback directly to Mr. Ware regarding his repeated expressions of interest in acquiring the Company. However, the Company issued a press release on February 11, 2009 announcing that the Company's Board of Directors had unanimously rejected Mr. Ware's proposal to acquire the Company.

In light of the Company's public rejection of Mr. Ware's offer and the Company's announcement committing to engage in strategic alternatives to enhance shareholder value, Mr. Ware is no longer interested in acquiring the Company, although he remains interested in the Company as a more passive shareholder. Prior to the Company's announcement on February 11, 2009, Mr. Ware and Mr. Cook sold shares because of the lack of response to Mr. Ware's proposal and the increase in the market value of the Common Stock. Mr. Ware and Mr. Cook may decide to purchase or sell additional shares in the future in open market transactions, depending on the market price of the Common Stock. Mr. Ware and Mr. Cook have no present plans or proposals which relate to or would result in:

- a. The acquisition by any person of additional securities of the issuer, or the disposition of securities of the Issuer;
- b. An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Issuer or any of its subsidiaries;
- c. A sale or transfer of a material amount of assets of the Issuer or any of its subsidiaries;
- d. Any change in the present board of directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- e. Any material change in the present capitalization or dividend policy of the Issuer;
- f. Any other material change in the issuer's business or corporate structure;
- g. Changes in the issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Issuer by any person;
- h. Causing a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- i. A class of equity securities of the Issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act;
or
- j. Any action similar to any of those enumerated above.

Item 5. Interest in Common Stock of the Issuer

(a) and (b) Mr. Ware owns 444,230 shares of the Common Stock, over which he has sole dispositive and voting power, constituting approximately 1.2% of the total shares outstanding. Mr. Cook no longer owns any shares of Common Stock.

Other than the attorney-client relationship, there are no other contracts, arrangements, understandings or relationships between Mr. Cook and Mr. Ware with respect to the Common Stock. Mr. Cook and Mr. Ware each disclaim beneficial ownership over the shares of Common Stock owned by the other.
