MCNAMARA IS A TRUSTEE OF THE RICHARD MCNAMARA FAMILY FOUNDATION WHICH HOLDS 294,250 SHARES OF THE ISSUER'S COMMON STOCK AS OF DECEMBER 31, 2003. MR. MCNAMARA DISCLAIMS BENEFICIAL OWNERSHIP OF THE ISSUER'S COMMON STOCK HELD BY THE RICHARD MCNAMARA FAMILY FOUNDATION.
