- (1) In an exempt disposition to the Issuer under rule 16b-3(e), the Reporting Person remitted shares to the Issuer in connection with the satisfaction of tax withholding obligations arising out of the vesting of previously reported restricted stock units, or RSUs.  
The Form 4 filed by the Reporting Person on September 19, 2014 reported that 210,211 shares were transferred from the David Flynn 2012 Annuity Trust dated December 20, 2012 (the "Annuity Trust") to the Reporting Person; such number of shares transferred was actually 210,111.
