The Registrant's board of directors has also determined that they are independent, as that term is defined in the applicable listing standards of the Nasdaq Stock Market, Inc.

## **PRINCIPAL ACCOUNTANT FEES AND SERVICES**

### **Audit Fees**

The fees charged by Deloitte & Touche LLP for audit services for the year ended December 31, 2004 were Cdn\$978,000 (2003: Cdn\$772,000).

### **Audit Related Fees**

The fees charged by Deloitte & Touche LLP for the year ended December 31, 2004 for offering documents were Cdn\$534,000 (2003: Cdn\$141,000), for the review of the Sarbanes-Oxley work prepared by the Company were Cdn\$138,000 (2002: nil) and the audits of employee benefit plans were Cdn\$46,000 (2003: Cdn\$44,000).

### **Tax Fees**

The fees charged by Deloitte & Touche LLP for U.S. tax compliance and planning work for the fiscal year ended December 31, 2004 were Cdn\$213,000 (2003: Cdn\$270,000).

### **Other Fees**

D&T did not charge any other fees in 2003 or 2004.

### **Independence of Auditors**

D&T and the audit committee of the Company have considered all relationships between D&T and its related entities and the Company and its related entities in light of the independence standards issued by the Independence Standards Board and have determined that the non-audit services provided by D&T to the Company are compatible with maintaining D&T independence.

Since the enactment of the Sarbanes-Oxley Act of 2002 on July 30, 2002, all non-audit services performed by the Registrant's auditor are required to be approved by the audit committee of the Registrant.
