Elbit Systems Announces the Results of its  
Annual General Meeting of Shareholders Held on November 30, 2011

Haifa, Israel, December 1, 2011 - Elbit Systems Ltd. (NASDAQ and TASE: ESLT) (the "Company") announced today that at its Annual General Meeting of Shareholders (the "Meeting") held on November 30, 2011 at the Company's offices in Haifa, the proposed resolutions described in the Proxy Statement to the Shareholders dated October 25, 2011 (the "Proxy") and detailed hereunder, were approved by the required majority:

1. that Messrs. M. Federmann, Arad, Asheri, D. Federmann, Ne'eman and Ninveh and Mrs. Baum are elected as directors of the Company until the close of next Shareholder's Annual General Meeting of the Company.
2. that the Company's Articles of Association are amended as reflected in Sections A (as amended pursuant to the Company's 6K Report of November 23, 2011), B and C of Annex A of the Proxy.
3. that the Amended Indemnification Letter in the form of Annex B of the Proxy is approved for provision by the Company to the directors of the Company, including to Mr. M. Federmann and Mr. D. Federmann, who are considered direct or indirect controlling shareholders of the Company.
4. that the Company's independent auditor, Kost, Forer, Gabbay & Kasierer, a member of Ernst & Young Global, is appointed as independent auditor of the Company for the fiscal year 2011 and until the close of the next Shareholders' Annual General Meeting of the Company.
