- (1) On December 7, 2007, the Reporting Person was granted 3,000 shares of Restricted Stock as compensation for service as an officer of the Issuer. Each Restricted Stock grant consists of a right to the issuance of one share of common stock, par value \$0.01 ("Common Stock"). The Restricted Stock is subject to a three-year vesting period.
- (2) As of the date hereof, the Reporting Person directly beneficially owned 139,511 shares of Common Stock, 2,000 shares of Restricted Stock, 4,756 shares of Common Stock in Enzo Biochem's 401(K) Plan and 55,477 options to purchase Common Stock, par value \$0.01 per share, which are exercisable within 60 days from the date hereof. This number does not include 5,000 shares of Restricted Stock that will not vest within the 60 day period.
