DTE Energy Company ("DTE Energy") will meet with investors at the UBS Natural Gas, Electric Power and MLP Conference March 3-4, 2015. In the meetings and the presentation, DTE Energy reaffirms its 2015 operating earnings per share guidance of \$4.48-\$4.72 per share.

In its slide presentation and this filing, DTE Energy discusses 2015 operating earnings guidance. It is likely that certain items that impact the company's 2015 reported results will be excluded from operating results. Reconciliations to the comparable 2015 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
