TELECOM ITALIA: DEFINITION OF TERMS FOR \$4 BILLION BOND ISSUE

Milan, 22 October 2003 - Telecom Italia and Telecom Italia Capital S.A. announce that the bookbuilding and definition of terms for the debut multi-tranche USD fixed-rate benchmark issue was completed today.
The issue, offered to qualified institutional investors in the United States pursuant to Rule 144A of the US Securities Act of 1933 and to investors outside the United States pursuant to Regulation S under the US Securities act of 1933, is part of Telecom Italia s plan to refinance short and long term debt , approved by the Board of Directors on 10 October 2003.
The total size of the bond issue was set at \$4 billion, split among three tranches with a maturity of five, ten and thirty year.
