Capital Group International, Inc. ("CGII") is the parent holding company of a group of investment management companies that hold investment power and, in some cases, voting power over the securities reported in this Schedule 13G. The investment management companies, which include a "bank" as defined in Section 3(a)(6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 5,181,790 shares or 3.1% of the 169,291,649 shares of Common Capital Stock, including American Depositary shares, believed to be outstanding.

Shares reported by Capital Group International, Inc., include 89,870 shares resulting from the assumed conversion of 52,460 shares of the Series III Convertible Preferred Stock.

Shares reported by Capital Group International, Inc. include 2,366,950 American Depositary Shares, representing 2,366,950 shares of the Common Capital Stock.
