Capital Group International, Inc. ("CGII") is the parent holding company of a group of investment management companies that hold investment power and, in some cases, voting power over the securities reported in this Schedule 13G. The investment management companies, which include a "bank" as defined in Section 3(a)(6) of the Securities Exchange Act of 1934 (the "Act") and several investment advisers registered under Section 203 of the Investment Advisers Act of 1940, provide investment advisory and management services for their respective clients which include registered investment companies and institutional accounts. Capital International Investors, a division of Capital Research and Management Company, shares investment research and proxy voting decision making with CGII management companies. Shares managed by Capital International Investors are reported in aggregate with CGII. CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 1,163,886 shares or 0.8% of the 151,073,962 shares believed to be outstanding.

CGII, its investment management subsidiaries and Capital International Investors division of Capital Research and Management Company collectively provide investment management services under the name "Capital International Investors."

Capital International, Inc. ("CIInc"), an investment adviser registered under Section 203 of the Investment Advisers Act of 1940 is deemed to be the beneficial owner of 759,150 shares or 0.5% of the 151,073,962 shares believed to be outstanding as a result of acting as investment adviser to various investment companies and institutional accounts.

Shares reported by Capital Group International, Inc. include 581,943 American Depositary Shares, representing 1,163,886 shares of the Class A Ordinary Shares.
